## **Information Collection, Use, and Sharing**

We are the sole controllers of the personal data collected on this website as the service provider. We only collect information that you voluntarily provide to us – for example, via email, website forms, or other direct contact. We do not sell, rent, or otherwise disclose this information to third parties.

We use the information you provide solely to respond to your inquiry or to carry out the purpose for which you contacted or registered with us. The legal basis for processing this data is your consent, or our legitimate interest in responding to your requests and maintaining our services. We do not share your information outside of our organization, except where necessary to fulfill your request – for example, to deliver materials or process a transaction.

Where required, we may share information with trusted service providers who support our operations (such as web hosting or email delivery services), under

appropriate data protection agreements that comply with applicable laws and regulations.

In addition to the information you choose to provide, the server hosting this website automatically records standard access logs, which may include your current IP address and, for registered users, your username. These logs are retained for a limited period and are used solely for technical and administrative purposes – such as monitoring website traffic, performance, and usage patterns. IP addresses are treated as personal data under applicable data protection regulations.

## **Your Rights and Choices**

You may exercise the following rights at any time by contacting us via our email address or through the channels provided on our contact page:

- Request access to any personal data we hold about you.
- Request correction or updates to any data we hold about you.
- Request deletion of your personal data.

- Object to our processing of your personal data where it is used for purposes such as website security, traffic monitoring, or performance analysis, based on our legitimate interests.
- Raise any concerns regarding our use of your data.

We will not subscribe you to mailing lists or send you marketing communications without your explicit consent. We will only contact you in response to your inquiries or in connection with services you have subscribed to. You may opt out of future communications from us at any time by notifying us.

If you have created a user account and provided personal data in connection with a service subscription (for example, personal information, questions, or comments), please note that requesting deletion of your account and data will result in the loss of access to future content updates. In such cases, content already shared publicly with other users or with us (such as questions or comments) will be anonymized rather than deleted.

Please note that in some cases, we may be required to retain certain information for legal, security, or operational reasons, even if you request deletion. We aim to process all data-related requests without undue delay, and in any case within 30 days of receipt.

## **Security Precautions**

We take appropriate technical and organizational measures to protect your personal information, both online and offline. Where personal information is collected via this website, it is encrypted and securely transmitted. You can verify this by looking for the lock icon in your browser's address bar and the use of "https" at the beginning of the web page address.

Access to personal information is restricted to authorized individuals who require it in order to provide services to you. The computers and servers where personal data is stored are protected against unauthorized access, and we maintain appropriate safeguards to ensure the security of your information.

## **Use of Cookies**

Cookies are small pieces of data that are downloaded to your computer or mobile device when you visit a website. By default, we do not set any cookies that track or identify you across visits to this website.

We do not use or permit third-party tracking cookies, analytics cookies, or other types of third-party cookies.
